1. The Palestine Strategic Report 2020–2021 (Arabic)

The Palestine Strategic Report (PSR) is one of al-Zaytouna's most important academic studies, published in both English and Arabic since 2005. PSR reviews biennially the various developments concerning the Palestine issue in a comprehensive, objective and academic manner. It offers a wealth of data, up-to-date statistics, and analyzes and offers an outlook of future events.

This report that adheres to the principles of academic objectivity and accuracy of information, is the product of a massive team-work exerted by a group of affiliated researchers and specialists. Today, it can be surely asserted that PSR is a must reference for every researcher and academic who are interested in the contemporary developments of the Palestine issue, including: university professors,



students of history, sociology and political science, writers and journalists. The Centre held a press conference, on 11/1/2022, announcing the conclusions and results of the strategic report, and it was covered by various media outlets.

The PSR 2020–2021 tackles in eight chapters: the internal Palestinian scene, the Palestinian demographic and economic indicators, the Land and the holy sites, and the aggression, resistance and the peace process. In addition, it focuses on the Israeli scene including the most prominent Israeli political, demographic, economic and military developments, and the Israeli-Palestinian relations. It studies the Arab, Islamic, and international stances towards the Palestine issue, in addition to the 2022–2023 prospects for the Palestine issue.



3. The Palestine Daily Chronicle of 2021 (Arabic)

The Palestine Daily Chronicle is considered one of the most important books published by al-Zaytouna Centre. This book addresses the most prominent events related to the Palestine issue, documenting its daily important events, decisions and stances that express the nature of a phase or reflect the changes in political tracks.

The book puts forth information and statistics of significance, related to both the Palestinian and Israeli sides. The information include various aspects of Palestinian political, economic, cultural, social and educational performance, information about Jerusalem, and the performance of the resistance. 

5. The Palestine Issue: Historical Background and Contemporary Developments (Revised and Updated Version)

This book is important to those who want to acquaint themselves with the Palestine issue, and to become informed of the pertinent facts in a balanced manner. It can also serve as an introduction to further studies about the issue. This revised and amended version covers the Palestine issue developments until 2021.

The book discusses the historical background and contemporary developments. It is written in a smooth language, all the while retaining a scientific, academic and documented wording. It reviews Palestine's history through the ages, its geography, its Islamic standing, and the Jews'



religious and historical claims in Palestine. It discusses the period of the British occupation of Palestine and the establishment of Israel. It reviews the issue's developments, focusing on the development of the Palestinian struggle, revolutions and *Intifadahs*, in addition to the developments in Israel, the peace process, the role of the Palestine Liberation Organization (PLO), its factions and the role of the Palestinian Islamic movement.

6. Israeli Settlement in the West Bank From an International Law Perspective (Arabic)

The study deals with the Israeli settlement in the West Bank (WB), since its occupation in 1967 until 2017. The author defines the legal dimensions of the Israeli settlement building from an international law perspective, explaining the legal violations it represents. He also states the means available to confront it, while identifying the obstacles. For none of the international resolutions issued by the UN Security Council and General Assembly, which call for an end to Israeli settlements, have been implemented. Then, the author explains the damage caused by the settlements to the Palestinian people.

7. Faustian Bargains: Israeli Penetration of the Central Asian Republics (Arabic)

The book discusses the geostrategic and geopolitical importance of the Central Asian region in the Israeli strategic thought, and the reasons of Israel's inclination towards its republics, whose location is strategic and are rich in natural resources.

The author outlines five dimensions of Israeli interest in the Central Asian republics; a geographic dimension that allows it to get close to Russia, China, Turkey and Iran; the role of the agent where Israel is a foothold for the US on the Chinese, Russian, Afghan and Iranian borders; an economic dimension due to the richness of the region in energy sources; a military dimension being a market for Israeli military production; and a dimension of tracking and combating "Radical Islam" in cooperation with surrounding countries.

8. Five Thousand Days in the World of Barzakh (Isthmus): The Memoirs of the Prisoner Hassan Abd al-Rahman Salameh in Solitary Confinement in Israeli Prisons (Arabic)

The 224-page book is the diaries of Palestinian prisoner Hassan Abd al-Rahman Salameh, who was sentenced by the Israelis to 48 life sentences and 35 years in prison, of which he spent about five thousand days in solitary confinement; a life closer to the world of the dead "isthmus."

The author is the well-known Qassam military leader, who carried out "The Holy Revenge" operation in retaliation for the 1996 assassination of Ayyash, and became a fugitive from the Israeli forces. After being seriously injured, he was arrested and he is still now detained in Israeli prisons.

This is one of the most important books that describe the suffering of prisoners in Israeli prisons. It is a historical testimony and document that exposes the ugliness, injustice, oppression and inhumanity of the occupation.



The book discusses the stages of the negotiations of Devotion of the Free deal since the capture of the Israeli soldier Gilad Shalit in June 2006, until the completion of the exchange process in October 2011, leading to the liberation of hundreds of Palestinian prisoners from the Israeli prisons. It discusses the political and military circumstances that had an impact on negotiations, in addition to the obstacles, as well as the efforts made by various mediators to complete the deal.






13. Until the Last Breath: The Military Resistance Groups in Silwad Town, Palestine 1967–1971 (Arabic)

Third: Strategic Assessment

This assessment is a periodic report characterized by its rich material. It seeks to study a particular incident or issue and anticipate its future developments. It highlights the likeliest scenario and then ends the assessment with some suggestions and recommendations.

The strategic assessment usually addresses the Palestine issue and the related Arab, Islamic and international dimensions. In addition, it tackles other issues, which fall within the Centre's interests.

Al-Zaytouna Centre had published 130 strategic assessments by the end of 2022, including 8 assessments, of which 2 are strategic assessments that were published in 2022 and addressed the following topics:

Fourth: The Translation

The Translation Department at al-Zaytouna Centre translates most of the Centre's publications, including books, studies, and articles, in addition to covering the Centre's activities, posting most of them on the Centre's English website. It keeps its English-speaking audience, including experts and activists, informed of the latest developments concerning the Palestine issue.

During 2022, the Translation Department published the translations of 15 academic papers, 16 articles, two strategic assessments and two situation assessment.

The department issues the Arabic series "The Translation Series." It sheds lights on the most prominent articles and studies published by western or Israeli think tanks, which have an impact on the decision-making process in Israel and the west. Until the end of 2022, 90 Arabic translations were published, among which three were published in 2022, as follows:

- 1. The Israeli Society's Sensitivity to Casualties and its Influence on Decision-Making in Military Issues.
- 2. An Illusory Entente: The Myth of a Russia-China-Iran "Axis."
- 3. Renewing US Security Policy in the Middle East.



Fifth: Information and Archives

The Information and Archives Department has an essential role in the work of al-Zaytouna Centre. The department daily follows the most important Arab, foreign and Israeli newspapers, news sites, Israeli and foreign research and study centers.

Apart from its regular work, the department provides information assistance to many researchers and academics, besides preparing several news reports on important current issue. The department also issues "Palestine Today," an Arabic daily electronic newsletter dealing with all issues related to the Palestine issue and the Arab-Israeli conflict. "Palestine Today," is issued without interruption throughout the days of the year where the department daily follows dozens of news sources in order to achieve this work.

The electronic newsletter provides rich material for researchers and specialists sparing them time and effort. It is characterized by an academic categorization, by which news can be easily browsed. After the news had been re-edited while maintaining their basic content, they are classified in an easy and comprehensive tab.

This electronic newsletter is freely available on the center's website. By the end of 2022, the Centre had published 6,022 issues, out of which 300 were published the same year.



The Information and Archives Department also publishes the Information File series, which contain detailed academic studies with rich information, providing the researchers and specialists with detailed, clear, accurate, and well-documented material. Until the end of 2022, 30 volumes were published, among which one was in 2022, as follows:

1. The Role of the Religious Zionism and Its Impact on Israeli Politics 2020–2022 (Arabic)

The book studies the role of the religious Zionism movement in Israeli politics (January 2020 – September 2022). It discusses the most important news, reports and articles that discuss the role of the religious Zionism movement and its impact on Israeli politics, and the judicial, security and military institutions. It also discusses the role of the movement in promoting Judaization and settlement projects, its position on the peace process plans and its impact on the conflict with the Palestinians.

Noted that the Archives and Information Department has prepared this Information File (30), with Prof. Dr. Mohsen Mohammad Saleh as editor-in-chief and Dr. Basem Jalal Elkassem as the managing editor.



Sixth: The Website (alzaytouna.net)

In 2022, al-Zaytouna Centre Arabic and English websites have undergone a number of updates that are considered a qualitative leap in facilitating browsing, and highlighting the content of the site. The main menu has been reclassified, followed by sub-divisions that make access to the wide and diverse content of the site easier and more enjoyable.

The IT team have adjusted, monitored and corrected some technical problems and uploaded materials, improving the Website's service quality.

The site updates its visitors with the latest news of the Centre, its activities and publications. During 2022, we uploaded 170 of our publications on our website, in addition to 300 issues of "Palestine Today" electronic newsletter. Visitors can access a wide range of materials and services including the Strategic Assessment and al-Zaytouna translation series, in addition to a large collection of articles, studies, reports, documents, maps, infographics and selected books. Hence, our website is one of the richest in materials among Arab Think Tanks websites.

To encourage the spread of information, the site offers visitors free downloads of a number of the Centre's publications. The download includes The Palestine Strategic Report, the Information Report series and other valuable books. Tens of thousands of downloads were done, making it the top website among similar Palestinian ones, in terms of the number of visitors and downloads.

In 2022, the Centre has developed some features of its Android app. It launched its Instagram account, while its other social networking sites have been getting wide audience interaction, whether on its Facebook, Twitter, LinkedIn and SoundCloud platforms, while the YouTube page was re-launched after it was closed.



Seventh: Conferences and Panel Discussions

To spread awareness on regional events at local, regional and international levels, the Centre holds panel discussions in accordance with its policy of openness to all ideas and intellectual and political trends. These specialized, scientific, objective, and free discussions address key issues and topics concerning the Palestine issue. Hence, attaining results that best serve the Centre's stated objectives.

The discussions bring together a selection of specialists, researchers and experts on the Palestine issue from around the world. They are highly organized and covered by the media.

These panel discussions are an important source for preparing books, reports and strategic assessments. The Centre publishes the minutes of the discussions on its site for the audience to benefit from them.

Up to the end of 2022, the Centre had held 69 conferences and panel discussions, out of which 6 were held in 2022, and they are:

1. Panel Discussion: The Palestine Issue: Strategic Evaluation 2021 – Strategic Assessment 2022

(12/1/2022–Zoom)

Al-Zaytouna Centre for Studies and Consultations held on Zoom, a panel discussion, where a group of researchers, scholars, specialists and those interested in the Palestine issue participated. They discussed the internal Palestinian scene, the conditions in Jerusalem, the internal Israeli scene and the peace process. Furthermore, they discussed the normalization process, Iran and Turkey and their relations with the Palestine issue, as well as the international and US influence on the Palestine issue. The participants made many important interventions that enriched the discussions.



2. Panel Discussion: The Possible Scenarios of the Internal Palestinian Situation in Light of the PLO Central Council Meeting and the Options to Deal with It

(22/2/2022–Zoom)

Participants included researchers and experts specializing in Palestinian affairs from Palestine, Jordan, Lebanon, Qatar, Turkey and Malaysia. The writer, researcher and editor-in-chief of *Assabeel* newspaper, 'Atef al-Joulani presented five scenarios for the future of the internal Palestinian situation after the Palestinian Central Council (PCC) crisis. Participants considered implementable Palestinian reconciliation is a must. However, it must not be dependent on the mood of the Palestinian leadership, which has proved not to be



serious about reconciliation. They agreed that the required step is to justify the establishment of national alignment, and define its vision, objectives, parameters, policies and jurisdiction, in addition to putting a realistic plan.

3. Panel Discussion: The Impact of the Russian-Ukrainian War on the Palestine Issue

(16/3/2022–Zoom)

The main panelists of the panel discussion were four experts who discussed their working papers, and dozens of researchers and experts specialized in Palestinian, Arab and international affairs participated. They discussed the Russian-Ukrainian war and the ensuing international political, economic and geopolitical changes that may affect the Palestine issue.



4. Panel Discussion: The Israeli Aggression on Gaza Strip and Its Aftermath

(10/8/2022-Zoom)

A group of researchers and experts specialized in Palestinian affairs participated in this panel discussion, where the objective was to conduct a situation assessment of the Israeli aggression on Gaza Strip (GS), on 5–7/8/2022, and evaluate the performance of the resistance.



5. Panel Discussion: Multipolarity and the Shifting Alliances in the Middle East

(15/11/2022–Zoom)

The participants were a group of heads of think tanks, researchers and experts specialized in international relations, from Turkey, Malaysia, Russia, China, the United States, France, Poland, Britain, South Africa and a number of Arab countries. The objective was to assess the current international developments and changes and their impact on the alliances in the Middle East. It was held at a time where the Middle East was going through critical and complicated conditions. The main panelists



made four academic interventions, and there were important interventions and questions from a number of experts and specialists, and it was concluded by the answers and clarifications of the main panelists.

6. Panel Discussion: Eastern Mediterranean Gas and Its Impact on the Regional Geostrategic Landscape

(13/12/2022–Zoom)

A selection of experts specialized in political, economic and energy affairs participated, where they discussed the impact of gas investment on the geostrategic landscape in the Eastern Mediterranean region, and the expected repercussions at the international and regional levels and on the relations between regional countries. There were three main panelists, who discussed their important papers, after which a number of experts and specialists shared their view, enriching the session and covering the topic from its various aspects.





Eighth: Consultations and Training

Al-Zaytouna Centre continued holding training courses and conducting consultations in 2022. Consultations were offered to more than 20 researchers and institutions, among which were many theses and dissertations. 80 studies were evaluated and peer reviewed, and were sent to al-Zaytouna for publishing.

As for the training courses, two were held during 2022, as follows:

- 1. The *Bayt al-Maqdis* Sciences Course Advanced Level, held by Multaqa al-Quds al-Thaqafi–Jordan, where al-Zaytouna presented the two parts of the training course "100 years of resistance in Palestine," on 19/1/2022 and 26/1/2022.
- 2. A training course on preparing the Palestine Strategic Report, on 26/7/2022.

Ninth: Scientific Cooperation and Public Relations


The Centre was keen in 2022 to continue its academic relations with those who are interested and specialized in political and strategic studies. Besides those who are engaged in decision making in the region. This is in consistence with its policy of openness to actors and institutions involved in decision making, in addition to its openness cooperation and integration with the universities and centers working in the same domain. The Centre keeps in touch with them through conferences and seminars, visits and media.

The Centre's network of contacts includes politicians, academicians, researchers, think tanks and other figures working in the field of public policies related to the Middle East and the Palestine issue. In this context, al-Zaytouna gave special attention to communicating with the Palestinian decision makers at home and abroad; the PLO, PA and different factions and political actors in the Palestinian arena. During 2022, about 1,500 of those were contacted by al-Zaytouna, in addition to thousands of its subscribers.

During the year 2022, the Centre sought to provide its research to researchers on specialized platforms. It uploaded more than 200 academic papers on the ResearchGate platform, and over 340 academic papers on the Academia platform, while continuing to having its publication on EBSCO and Al-Manhal platforms.

In 2022, and as part of the academic cooperation, al-Zaytouna Centre prepared and published the book, *Studies on Normalization with the Zionist State: The Award-Winning Studies of the International Research Competition "No to Normalization."* The 510-page book consists of 13 refereed studies, and the competition was in collaboration with PALM Strategic Initiatives Centre – Malaysia, the General Authority for Youth and Culture – Gaza and Elmessiri Academy for Research and Studies – Gaza. The book was edited by the academic editing team of al-Zaytouna Centre.

Tenth: Al-Zaytouna in the Media

The Centre is keen to reach out to its audience. Its Public Relations and Media Department communicates with the various satellite channels, news agencies, local and international sites and websites, to introduce its activities and publications and to provide media coverage for the events it holds. In this context, the Centre supplies these institutions with the latest news on published books and summaries about the panel discussions, conferences and any other events it might organize. In addition, al-Zaytouna provides media outlets with the latest information reports and strategic assessments it publishes.

It is also keen to accept media invitations to introduce the work of the Centre and its activities, or to comment on the major events within its domain, and participate in the fora and discussions on the different events.

During 2022, the Public Relations and Media Department issued 110 press articles about the activities of the Centre and its works, and documented these articles' publication in 130 different media sources including newspapers, magazines, news agencies and websites. It also documented the publication of dozens of press articles about the Centre and its work in the media, other than the material published by the department itself.

In 2022, the department documented the participation of two of the Centre's researchers and representatives in tens of interviews with media institutions, including TV channels, radio stations, newspaper, news agencies and websites. Most of these events have focused on the issue of Palestine and the Arab-Israeli conflict.
